We are seeing a world in transition, rapidly changing and it is imperative for us as a church to acknowledge these changes so that we can better answer the needs of the people. We can be victims of change. but we can be its authors as well as its guardians. Can we be examples of what it is to respond and at the same time to lead, to change boldly, but to hold to what is true faithfully as well? What are we to do in the midst of a rapidly changing culture? A church in dialogue? A church that listens? A humbler church? But the other side of us is anxious that we might be compromising the Gospel and moving with the world rather moving the world with the power of God. We have entered a highly specialized generation in medicine, in commerce, in engineering, in communication technology — there is an expert in everything. What is the church an expert of? Jack of all trades and master of none? What is our expertise that would necessitate people to come? We must daringly and honestly ask ourselves whether or not our church provides answers to the vexing problems in human hearts, the skepticism of many of the young, and the indifference of those who think that the days of religion have given way to the age of science. We have our liturgical pomp and pride but are our rituals connected to the hopes and frustrations, the joys and grief of the people? Are we still understood and relevant to the struggles and visions of our people? Can we listen to gutter language without judgment? The transitions need our attention. The shifts in paradigms need shifts in our approaches. A defensive church will not inspire and ignite souls. Let us search for answers and ask the Holy Spirit to inspire and set our hearts on fire.

Convention Rules of Order

SECTION XV – RULES OF ORDER (By-Laws)

Item 1. Debate and Decorum:

- (a) Every delegate and Minister shall have the right to speak once on all questions. After all those desiring to do so have spoken she/he shall have the right to speak again.
- (b) Every delegate and Minister shall obtain the recognition of the chair before speaking.
- (c) The mover of any proposition shall have the right to close the debate.
- (d) Every delegate and Minister shall confine herself/himself strictly to the question before the Convention.

Item 2. Voting:

- (a) Every delegate and Minister shall have the right to vote on all questions.
- (b) Any delegate or Minister shall have the right to have his/her dissent, with reasons, recorded on any question or part thereof.

Item 3. Motions and Resolutions:

- (a) Every delegate and Minister shall have the right to make a motion or offer a resolution.
- (b) Every motion or resolution shall be presented to the Secretary in writing.
- (c) Every motion or resolution, unless otherwise indicated, shall require for confirmation a majority vote of the voting body present.

Item 4. Rules of Order:

All parliamentary rules and practices not covered by the Constitution and By-Laws shall be determined by Robert's Rules of Order latest edition.

Convention Minutes #902

Theme: Liberated by God's Grace

The following are the Minutes of the 74th Annual Convention of the Evangelical Lutheran Church in Guyana held from 30th April to 2nd May 2017 at Ebenezer Lutheran Church, New Amsterdam, Berbice.

1. Sunday 30th April, 2017: Opening Worship

The Opening Worship Service began with a procession led by the Cofona Band around the block at 8:45h then was followed by 'singspiration' led by Mr. Michael Davy Ram and assisted by the Guyana Lutheran Music Academy Teachers.

2. Summary of Worship Message

Rev. Leroy Nicholson reflected on the theme: Liberated by God's grace. John 8:32; And ye shall know the truth, and the truth shall make you free. Some people are all about the truth, the whole truth, and nothing but the truth. The famous atheist Thomas Huxley admitted; "A man's worst difficulties begin when he is able to do as he likes." The dirty little secret of all mankind is we are all sinners, enslaved to sin and the consequences of sin.

We need liberation from sin; liberation to live our lives in simple love and obedience to God and the Lord Jesus Christ. The good news of the Gospel is we can be liberated; but that liberation from sin has evidence; we must believe in Jesus, abide in Jesus; when we believe in Jesus we experience salvation, when we abide in Jesus we walk in discipleship.

The result of salvation and discipleship are an understanding of truth and the ability to experience true liberation from sin. Paul the Apostle puts it this way. Romans 8:2; For the law of the Spirit of life in Christ Jesus has made me free from the law of sin and death. Many times we fail to see the true meaning and the true significance of the word "Freedom". For many the word "Freedom" means "free to do what I want", without consideration of moral or immoral content, moral or immoral consequence.

"There are two freedoms—the false, where a man is free to do what he likes; the true; where a man is free to do what he ought." We can choose a way that is opposite to God's way, and we wind up with tragic consequences and regrets.

We stumble in the dark, we are tangled in sin, strangled by disobedience, until we can only taste the bitter and rancid bile of Spiritual death, so long as we are in bondage to sin we are never truly free. Jesus has freed us from sin and for service. Freedom from sin begins with believing and accepting all that Jesus says is true. All that Jesus says about God, all that Jesus says about the terror and horror of sin, and that Jesus says about the real meaning of life.

3. Commission of New Deacons

Having been examined and approved for commissioning by the Executive Council, and accepted the Call, the Assembly witnessed the commissioning of four Candidates, into the Diaconate Ministry of the ELCG by the Rev. Leroy Nicholson, President:

The Secretary, Ms. Elocia Smith, presented certificates to the Deacons who were commissioned.

5. Opening Convention

The President, Rev. Leroy Nicholson formally declared the 74th Annual Convention of the Evangelical Lutheran Church in Guyana, to be in session.

6. Welcome and Greetings

The Secretary, Ms. Elocia Smith welcomed and extended cordial greetings to all including the ELCG's overseas partners.

Greetings were brought from: Rev. Thomas Unrath, FBS, Mr. Keith Myra, ELCIC, Rev. Urwin Holband, ELKS, Mr. Girma Gutema, Guyana Mission of Ethiopia, Rev. Phillip Rose from the NACCC and Rev. Cheryl Isaac of the Methodist Church.

7. **Meeting**

The Executive Council met at 3:10 p.m. with representatives of our overseas partners attending Convention – ELCIC, FBS and ELKS for discussion on matters of mutual interest and accompaniment. The matters discussed included lack of communication, need for information on Lay Academy, Leadership – Women, Men, Youth and Lay Leaders.

The main objective is to bridge the gap between ELCG and our Partners with ongoing communication, also to set goals and to encourage development in the areas of Leadership, Deacons, Treasurers, Lay Academy, Music Academy and Christian Education Department for, long term programming, areas of assistance, strategic planning and project.

The day's events concluded in the evening with a Talent Show with the GLMA students, which was held in the Ebenezer Lutheran Church sanctuary and led by the music teachers of the Guyana Lutheran Music Academy.

8. Assembly and Worship Devotion

Convention assembled at 8:00a.m. for worship. Devotion was conducted by Convention Chaplain, Deacon Mahendra Singh.

9 Convention Sessions

Hon. Sandra Kurtzious, Vice President, in line with the Constitution, presided at the Convention sessions. She welcomed and extended greetings to all in attendance.

10. Sub-theme

The first sub theme: **Revelation – Who God Is** was presented by lead presenter, Rev. Amanda Singh followed by discussions with moderator, Rev. Sugrim Gobin.

Rev. Amanda Singh reiterated on Revelation -Who God Is -- God as a Creator, God as a Person, God as Spirit and God is Love.

11. First Business Session

Eight (8) Ministers, twenty-four (24) Delegates and (4) Advisory Delegates were registered by the Secretary as voting members of Convention based on submission from Parishes.

17. President's Report

The President, Rev. Leroy Nicholson, in his report reflected on the theme: Liberated by God's Grace. He also reported on the general situation of the church including Pastoral Assignments, International Relations, Partnership Ministries, Standing Committees, Lay Academy, Youth Ministry, 500th Reformation Anniversary and Ministerium.

After discussion, Convention voted to receive the report of the President with appreciation and also approved the recommendations for appropriate actions by all concerned.

18. Vice President's Report

The Vice President, Hon Sandra Kurtzious reflected on Convention theme and her responsibility as Chair of the Executive Council. The report concentrated on contributions we make individually and as a Church as we prepare for God's Call in building membership and the auxiliaries in this part of his vineyard.

Convention received the report of the Vice President with appreciation.

19. The Second Sub-theme

The second sub theme: **Reformation- Who We Are** was presented by lead presenter, Rev. Shirley Jaundoo followed by discussions with moderator, Rev. Thomas Unrath.

Rev. Shirley Jaundoo explained "Who We Are" in the most profound way to the conventioneers.

She said that this anniversary gives us an opportunity to affirm and reaffirm the divine truths that God revealed through His servant Martin Luther as he was guided by the Holy Spirit. These Divine Truths, in Latin phrases have been called "The Five Solas" which emerged during the reformation, summarized then and now, the Reformers' Theological convictions about the essentials of Christianity.

- 1. Sola Scriptura (Scripture alone).
- 2. Solus Christus (Christ alone).
- 3. Sola Gratia (Grace alone).
- 4. Sola Fide (Faith alone).
- 5. Soli Deo Gloria (Glory to God alone).

Third Business Session

20. Secretary's Report

This report was presented by the Secretary, Ms. Elocia Smith who presented the work of the Executive Council, the Church-wide Statistics and recommendations.

After discussion, Convention voted to receive the report of the Secretary with appreciation and also approved the recommendations for appropriate action by all concerned.

Fourth Business Session

21. Report of the Treasurer

The Treasurer, Mr. Michael Davy Ram, presented the Treasurer's report as follows:-

The Treasurer's report included information on Income, Cash position, Bank reconciliation, Apportionment, Convention expenses, Convention project, Special funds, gifts/donations/bonuses, Overseas grants, Sale of properties and Assets and Capital acquisition. After discussions and explanations, Convention voted to receive the report of the Treasurer with appreciation.

The Auditor's Report by L.A. Atherly and Company, Chartered Accountants was presented by the Treasurer. After discussions and explanations, Convention voted to adopt the Auditor's Report.

The 2018 Church wide Budget: Following discussions, particularly on apportionment set at \$2,400.00 per active member, Convention voted to approve a budget that will not include an increase in apportionment.

22. Recommendations from the Treasurer

Recommendation:

- (i) A propose payment plan to receive all outstanding apportionment owing to ELCG from all the relevant Parishes by June 30th 2017.
- (ii) That the apportionment of \$868,110.00 owed by the Reformation Parish is forgiven and the Parish be exempted from apportionment until December 31st, 2020 after which the Finance Committee will take further action.
- (iii) That the designated funds for the Lutheran Home be directed to the Living Reformation Project.

The Treasurer's concerns were that the non-payments for apportionment is a sign of bad management by Parishes.

After discussions, Convention voted to approve the recommendations.

23. Campfire

A Campfire and closing devotion was led by Rev. Leroy Nicholson and youths of Ebenezer Parish.

Tuesday May 2nd 2017

Morning devotion was conducted by Deacon Sharon Sulker and Deacon Leeta Chutkhan.

24. Third Sub-theme

The third sub theme: **Revolution – Who Is Ready** was presented by lead presenter, Mr. Michael Davy Ram followed by discussions with moderator, Deacon Shelda Emanuel.

Mr. Ram stressed in his presentation that, to be truly ready, it is first through the Holy Spirit, daily Prayers and Commitment.

Fifth Business Session

25. A Proposal for the Living Reformation Project was presented by Ms. Lisa Jerome and Mr. Christopher Wordsworth who laid out a thorough plan to the 74th Annual Convention, 2017 of the ELCG.

Pledges totaling \$864,000.00 were received for the Living Reformation Project from the Convention.

27. 500th Reformation Anniversary Celebration in Guyana

Mr. Michael Davy Ram – Chair of the 500th Anniversary Celebration of Reformation Committee presented the proposed events for the celebrations in 2017. A number of suggestions and recommendations were made. Convention approved the plans for the Anniversary Celebrations.

28. Vote of Thanks

The Secretary Ms. Elocia Smith expressed grateful thanks and appreciation to all for their attendance, active participation and service in various capacities. Particular appreciation was expressed to the representatives of our overseas partners.

29. Closing Service and Close of Convention

The closing service of Word and Sacrament was conducted by Deacon Keith Hazel, Liturgist; Rev. Patrick Peters, Preacher and Rev. Babsie Pierre, Celebrant.

31. Next Date for Convention is 6th May, 2018.

32. Close of Convention

The Rev. Leroy Nicholson, President of the ELCG, using the Order for the Close of Convention, officially declared the 74th Annual Convention 2017 closed.

2. Comments

The Evangelical Lutheran Church in Guyana has (8) Pastors and (10) Deacons. To guarantee Pastoral services to all Parishes, the ELCG has assigned one Pastor in an acting capacity, and two Pastors have been designated "Oversight Pastors."

During the past year Mr. Arnold Baron and Mr. Hapworth Thom have assisted in the reformation Parish by conducting worship services and visitations in that Parish. The ELCG expresses its gratitude to Mr. Arnold Baron and Mr. Hapworth Thom for their invaluable service.

The effort to a sustainable ministry in the Reformation Parish was strengthened by a three-day visit by the President and two lay persons during the month of April, 2017.

3. Internship, Ordination and Assignments

Mr. Ackloo Ramsudh, Mr. Mahendra Singh, Ms. Sharon Sulker and Ms. Mavis Campbell have successfully completed their Internship/probation for the Diaconate Ministry and were examined by the ELCG Vocations Committee. They were recommended to the Executive Council, with whose approval they were commissioned during the opening service of our 74nd Convention.

4. Resignation/Retirement

The Executive council of the Evangelical Lutheran Church in Guyana received a letter of retirement from Rev. Sugrim Gobin with effect from 31st December, 2017.

The ELCG expressed heartfelt thanks to Rev. Sugrim Gobin for his invaluable service to the Evangelical Lutheran Church in Guyana.

5. Relationships

i. Lutheran World federation

The LWF is a Global Communion of Christian Churches in the Lutheran Tradition. The LWF acts on behalf of its member churches in areas of common interest, such as ecumenical and interfaith relations, theology, humanitarian assistance, human rights, communication and various mission and development. Its Secretariat is located in Geneva, Switzerland. The Rev. Martin Junge is the General Secretary.

The ELCG has been kept informed of development in the service of the LWF and has received invitations to participate in events sponsored and hosted by the LWF.

Mr. Christopher Wordsworth represented the Evangelical Lutheran Church in Guyana at a Lutheran World Federation (LWF) sponsored Human and Institutional Capacity Development Workshop (HICD) in Lima Peru for Member Churches within Latin America and the Caribbean held from the 14th to the 17th March, 2017. This workshop was a follow-up on the HICD Workshop held in the same territories and discussed the outcome of those workshops, more-so necessary guidelines to follow for the sustainability of our member churches.

The Evangelical Lutheran Church in Guyana was represented by Rev. Leroy Nicholson and Mr. Joshua Seepersaud at the Lutheran World Federation 12th Assembly held in Namibia, South Africa, from the 12th to the 16th May, 2017, during which time, the 500th Anniversary of Lutheran Witness Globally was Commemorated with grand service of Word and Sacrament on the 15th May, 2017. Mr. Michael Davy Ram attended in the capacity of Council Member of the Lutheran World Federation.

After recommendation from the Lutheran World Federation, and endorsement from the Evangelical Lutheran Church in Guyana-Executive Council, Mr. Michael Davy Ram now serves as Advisor to the Lutheran World Federation Committee on Finance for the period 2017-2023.

ii. Evangelical Lutheran Church in America (ELCA)

The ELCG continues to share a treasured relationship with the ELCA. Vocabulary has denied us the ability to find the more preferred words to express our gratitude for the presence and impact of Rev. Raquel Rodriquez over the years. We were blessed at our 72nd Annual convention in May, 2015 by her timely journey with us which has now come to an end through retirement. At this crossroad, we thank God for her committed and exemplary leadership. We also welcome The Rev. Jaime Dubon as the new Area Desk Director for Latin America and the Caribbean ELCA-Global Mission.

iii. Ministry Among Guyanese (MAG)

This Committee is located in the Metropolitan New York area and is the Executive Body of the Guyanese Lutherans in the diaspora. It comprises former Guyanese Pastors and Lay persons whose desires are to support the ministry of the E.L.C.G. However, our relationship with M.A.G. has become dormant.

iv. Wartburg Theological Seminary (WTS)

The E.L.C.G continues to be the preferred territory of Wartburg Theological Seminary (W.T.S) in Dubuque, Iowa in their Students' January Cross Cultural Immersion Program. The E.L.C.G has over the years, hosted several students through the kind partnership of the parishes which

received them. Sean Avery was the only student on the Cross Cultural Immersion Program in January 2018.

v. Lutheran Lay Academy

The Rev. Dr. Winston D. Persaud – Professor of Wartburg Theological Seminary continues to give support to the Evangelical Lutheran Church in Guyana in its preparation of Pastors and Deacons for their Christian Vocation. Dr. Persaud conducted sessions on the T.E.A.M. Program on July 22, 2017 in the Redeemer Parish hall, Sheriff Street Georgetown, and July 29, 2017 in the Lutheran Lay Academy Hall, New Amsterdam, Berbice. These sessions were conducted with primary focus on "Being Lutheran in the21st century: hearing the Witness to the Gospel in Luther's Hymns!

vi. Guyana Mission Network

The Guyana Mission Network continues to play a vital role in the life of the E.L.C.G under the leadership of the Rev. Dr. Winston Persaud. The G.M.N has been instrumental over the years in providing the Pastor's Diaries, Lutheran Study Bibles, with copy given to every Pastor and Deacon. It also provides Bibles and other literature for the Christian Education Department.

vii. Fellowship Lutheran Church

Fellowship Lutheran Church is an E.L.C.A Congregation in Tulsa Oklahoma. Since 1996 it has reached out to the E.L.C.G in many ways through various supporting programs and visits that have mutually enriched one another's ministries and missions. They have contributed toward assisting retired Pastors and were instrumental in establishing the Music Academy.

Dr. Erv Janssen, who has been instrumental in this partnership since its inception; even though he no longer holds the reign, is to be remembered in our prayers and expressions of Gratitude.

viii. Florida Bahamas Synod (FBS)

The Companion Synod relationship with FBS is one of accompaniment. The President of the E.L.C.G, the Rev. Leroy Nicholson recently attended the installation of the newly Elected Bishop of the FBS, Bishop Pedro Saurez on 20th January, 2018.

We are grateful for the service of accompaniment given to us by Mr. Thomas Unrath, and looks forward to its continuation through his successor, Rev. Kit Robison. The visit by Ms. Chris Klafs and two others to the ELCG last summer is evidence of a continuing relationship with FBS. Chris continues to make numerous trips to Guyana; some personal and some where she teamed up with others. Most, however, were on behalf of FBS.

A Tri-Party Memorandum of Understanding (MOU) has been drafted between the Florida Bahamas Synod, The Evangelical Lutheran Church in Suriname and The Evangelical Lutheran Church in Guyana and signed by the three parties.

ix. Evangelical Lutheran Church in Suriname (E.L.K.S)

Last year we were graced with the presence of team led by Brother Leendert Darnound and Rev. Urwin Holban at our 74th Annual Convention. We were also blessed with the presence of Rev. Kross as our guest preacher at our 2017 Reformation Service. As neighbors, we look forward for greater participation and continued dialogue with our mutual ministries.

x. Eastern Synod of the Evangelical Lutheran Church in Canada (E.L.C.I.C)

This partnership between the E.L.C.G and the Eastern Synod of the E.L.C.I.C has been strengthened since it was ratified almost 18 years ago during the 59th Annual Convention of the Church.

The short-term missionaries gracing us with their presence and service, is an example of the mutual support and value, the Eastern Synod of the E.L.C.I.C placed on this relationship.

We record with gratitude and appreciation the contributions of all those who, in a very sacrificial way, "blazed the trail" for more short-term missionaries.

The Eastern Synod – E.L.C.I.C in its partnership with the E.L.C.G has exhibited its continuous support and commitment through its financial contributions made and invitations extended to the E.L.C.G to attend Assemblies in Canada. The executive Council of the ELCG continues to have dialogues with the Eastern Synod through Tele-conferences.

6. <u>Ministries</u>

i. Christian Education Department

The Christian Education Department remains an integral dimension of the E.L.C.G. The Committee continues to take a "hands on" approach to the work of the CED with regular meetings to assess and advise on the work done at the department.

Besides supplying the needs for Sunday-school and Vacation Bible School, the department continues to produce Advent and Lenten Devotional booklets.

ii. Evangelical Lutheran Church Men

In spite of the abundance of experience, expertise, and talents existing among the men of the ELCG, the Church is still to realize the establishment of a National Men's Executive. The problem seems to be one of commitment. This is amusing since the men of the Church offer leadership in the Congregations, work-places, social organizations and committees. The time has come for the men of our church to garner their leadership skills and use them as good stewards in God's Mission.

iii. Evangelical Lutheran Church Women

The Evangelical Lutheran Church Women held its 35th Annual Convention from the 23rd to the 25th July, 2017 under the theme, *"Liberated by God's Grace."*

At their 35th Annual Convention a new National Executive Body was elected, with Sister Shelon Bruce elected President. For the year 2017, the National ELCW continued with their outreach program, National Day Service, Feeding Program, Health talk and Visitation.

iv. Church Vocations Committee

The Church Vocations Committee continues to provide an important service to the E.L.C.G. The following candidates were interviewed and recommended by the CVC:

Mr. Ackloo Ramsudh -Ebenezer Parish
Ms. Sharon Sulker -Transfiguration Parish

Ms. Mavis Campbell - Advent Parish Mr. Mahendra Singh - Advent Parish

These candidates were commissioned at our 74th Annual Convention and are currently serving in their respected Parishes.

v. The Guyana Lutheran Music Academy

The dream a Guyana Lutheran Music Academy was realized in September 2014 after dedication and selfless effort by musicians Eric Sayre and Mike Murchinson, support from Fellowship Lutheran Church, various groups in the United States of America and Guyana. For logistical reasons, the Guyana Lutheran Music Academy has been closed for a one-year period, from May 2017 and is expected to be reopened in September 2018.

7. Ministerium

The Evangelical Lutheran Church in Guyana Ministerium met on Thursday 16th March, 2017 in the Good Shepherd Parish. Pastors and Deacons were blessed with Pastor Amanda Singh sharing from the experience gained from her Clinical Pastoral Education Scholarship and Pastor Leroy Nicholson presenting on "The Sacrificial Law and the Church."

Ministerium is intended to allow Pastors and Deacons to lend/give support to each other with the challenges that come with being a Witness to Christ.

The bond among Pastors and Deacons was again strengthened by a Christmas social held on the 17th December, 2017, and was hosted by the Redeemer Parish.

In acknowledgement of the effect of grief upon the life of individual directly and indirectly, the ELCG Ministerium in partnership with the Rev. Dr. Dale Young held a two-day Grief Support Workshop on the 24th and 25th February, 2017 at the Redeemer Parish hall. This workshop was open to all Pastors, Deacons and Lay Persons.

8. Standing and other Committees

The standing Committees have always been an important instrument of the Church. Through the committees, specialized areas of ministry are undertaken with the broader involvement of the Laity. These committees include The Mission and Evangelism Committee, Church Vocation Committee, Christian Education and Literature Committee, Finance and Stewardship Committee, Committee on Worship and the Camp and Retreat Board. These Committees met on14th January 2017 at Ebenezer Lutheran Parish where they reflected on their achievements in light of their planned program for 2016 and also to plan for 2017.

9. Committee on Youth Ministry

Very early in 2017 the committee on Youth Ministry circulated its plans of activities. Under the leadership of the Chairperson Mr. Dave Bassoo and Director Mr. Wayne Melville, the Committee on Youth Ministry was determine in ensuring their plans were executed.

During the past year, the Chairperson Mr. Dave Bassoo resigned and was replaced by Ms. Dynutha Adonis. The N.Y.C recognizes the contribution of Mr. Dave Bassoo and expresses sincere gratitude.

All scheduled Activities were completed according to the calendar of the ELCG with a few additional activities.

10. Committee on Reformation 500 Anniversary

At the E.L.C.G. joint 2015 Reformation Service, a committee was commissioned with the responsibility to plan for the 500th anniversary Celebration of Lutheran witness. This committee

has done justice to its office of responsibility much to the satisfaction of worshippers at Reformation 2017.

11. Recommendations

- i. Considering the unique and diverse nature of each Parish in the E.L.C.G., Parishes should strive to share their **human** and **financial** resources where possible so that the entire Church can benefit.
- **ii.** Neighboring Parishes should seriously consider collaboration in some areas of ministry such as Luther League, E.L.C.W., E.L.C.M. and Revival Services so that bonds of friendship and fellowship may be built and make our Church more visible.
- **iii.** The E.X.C.O should continue its practice of support to Parishes through meetings with the Parish Councils, and that the confidence and respect of the audience be respected.

12. Acknowledgement/Conclusion

The presidency of the E.L.C.G has allowed me the privilege to visit parishes within the E.L.C.G. Some being official Parish visits whereas others were as guest preacher/speaker. Those visits also provided opportunities to discuss inter-personal relationships which affect God's mission and ministry.

Interactions in the Parishes were also based on discussions on how maximum usage of personnel, assets and resources can be realized since leaders are able to lead better when they have a reliable support base.

As another year as your President comes to an end, I wish to express gratitude to all the Members of the Executive Council. Special thanks to our Vice-president Sister Sandra Kurtzious for her honest feedbacks/transparent leadership and the Pastors for their prayerful support.

Also I wish to express thanks to my colleagues in the Ministerium, (Deacons and Pastors) and our very efficient and competent Administrative Secretary.

Last, but not least, I wish to thank my family, especially my wife Janice and friends for their unfailing love and support.

On a very serious note, please be advised that I am not available for re-election as the ELCG President nor a member of the Executive Council.

Report of the Secretary

Reflection: **Preaching, Teaching, Reaching – Our Church at the Crossroads!**

The Lord said to his people, "Stand at the Crossroads and look. Ask for the ancient paths and where the best road is. Walk in it, and you will live in Peace." But they said, "No, we will not!" Then the Lord appointed sentries to listen for the trumpet's warning. But they said, "We will not listen." So the Lord said, "Listen, you nations, and learn what is going to happen to my people. Listen, earth! As punishment for all their schemes I am bringing ruin on these people, because they have rejected my teaching and have not obeyed my Words. Jeremiah 6:16-19.

The theme for our convention this year; "Our Church at the Crossroads," is a definite admission which prompts us to ask, what has gone wrong? Who or what is to be blamed? The strong, confident, even triumphant institution that we remember from our youth or that others have told us about from decades ago is not what we and our children experience today.

To be what it is today, the church in every age had to acknowledge and accept her limitations and just entrust herself to God with the resources available to her. To pull negative labels out of the bag about our church at this time will further isolate and ostracise our members. In such a delicate and sensitive situation, support, encouragement and renewed commitment would be more beneficial and helpful.

The efforts of the Executive Council cannot go unnoticed, the ministry of the pastors, deacons and lay leaders must be recognised, the input of the youths are valuable, the women's group play their role and the Sunday school provide foundation.

ELCG'S task is to keep holding on, trusting God on the crossroad, refusing to become overshadowed with fear in difficult times and to continue to be what the faithful church is; a church preaching, teaching and reaching.

Work of the Executive Council and Church-wide Statistics

The Secretary is required to submit a report to the Annual Convention of this Church based on:

- I. The work of the Executive Council,
- II. The Annual Parochial Reports from all the Parishes.

Very thankfully, I commended the Parishes for the timely submission of their reports which created a smooth flow in the presentation of the statistics. I am pleased to report accordingly.

The Executive Council, met monthly during 2017 with the exception of May, due to Convention held in this month and August, 2017 respectively which most of the Pastors proceeded on Annual Leave. During the period under review the Council considered matters affecting the administration and life of the Church, and took decisions and made interventions on several matters, including:

- I. The appointment/assignment of Pastors, Acting Pastors, Contact Pastors and Deacons in Parishes.
- II. Ongoing relationships and partnerships with ELCA/DGM, Wartburg Theological Seminary, Fellowship Lutheran Church, Florida-Bahamas Synod, Lutheran World Federation, Eastern Synod of the Evangelical Lutheran Church in Canada, ELKS of Suriname, GMN of USA and MAG of USA.

- III. The continuing development of Pastors, Deacons and Lay leaders which provides intensive training through the interventions by Rev. Dr. Winston Persaud, Professor of Systematic Theology at Wartburg Theological Seminary, USA.
- IV. Parish administration workshops for Pastors, Deacons, and Officers of Parish Councils;
- V. The Executive Council sponsored a joint meeting with the Standing Committees on the 4th February, 2017 to review their Terms of Reference and to plan their programme of work for the year 2017.
- VI. Overseas representation, conferences; and Leadership Seminars.
- VII. Overseas resource persons for training interventions for the Ministerium and the Diaconate.
- VIII. Personnel matters and issues of concern involving clergy, Deacons, Staff and Parishes through interviews, dialogues, and meetings;
- IX. Matters pertaining to the Christian Education Department and the National Youth Ministry.
- X. The approval of four Candidates for the Diaconate Ministry who would be prepared through appropriate exposure, assignments, and training to be followed by the constitutional procedure for examination interview, and approval for commissioning.
- XI. Consideration and actions relating to property assets of the Church from the Property Committee under the Chair the Hon. Sandra Kurtzious, Vice President of the ELCG, Executive Council.
- XII. Incoming and Outgoing correspondences and regular reports from Officers.
- XIII. The Commissioning of four Deacons and the Retirement of one Pastor.

I am also pleased to present the Church-wide Statistics as submitted by Pastors/Parishes. There are still inaccuracies in the statistics from some parishes and reports of records/congregational registers not located. This situation in such parishes needs to be addressed by the Pastors, Deacons and Parish Councils.

While it is noted that the keeping of accurate parochial records of each Congregation is a constitutional duty of the Pastor, it is also by extension, the responsibility of Deacons, and Officers of Parish Councils in keeping with the framework of our Constitution and By-laws. Recommendations:

I wish to respectfully bring to this Convention, from the statistical viewpoint the following recommendations:

- I. According to Article VIII Section 7 (b) of the Constitution, all Parishes are required to submit the Minutes of their Annual Congregational Meeting.
- II. That serious consideration be taken in the growing declined of membership and active participation within the congregations, at the same time restructuring programs with a common vision and goals for ministry that inform the work of both the laity and members.
- III. To conduct a realistic evaluation of the Ministry is very important for every congregation. Take into consideration not only the leadership qualities of the pastor, but also the ministry provided by lay leaders and members of the Congregation. This builds a foundation for performance evaluation through prayer, conversation, and team building.
- IV. To establish a ministry review and performance evaluation process, periodic checks can help to keep the ministry on track. An annual review process can become an essential routine for healthy congregations.

Report of the Treasurer

Greetings in the name of our Risen Lord and Saviour Jesus Christ! The following is the report of the Treasurer for the year ended December 31, 2017.

1.0 Income

The Total Income for the Year 2017 was \$9,165,531: representing 89% of our 2017 Budget of \$10,250,000:. However, only \$5,012,994 (55%) represents local income, of which 15% (\$1,413,685:) are designated funds from local sources.

The remaining 19% (\$4,152,537:) was achieved through grants/gifts/refunds from the Evangelical Lutheran Church in America (ELCA), Fellowship Lutheran Church (FLC), Guyana Mission Network (GMN), the Lutheran World Federation (LWF) and Guyana Lutheran Music Academy (GLMA) tuition fees.

1.3 Apportionment

Apportionment budgeted for 2017 was \$2,348,000 coupled with net outstanding payments of \$4,608,247 puts total Parish apportionment outstanding as at Jan 01, 2017 to \$6,956,247:

During the year under review, we received payments totaling \$1,762,000: representing approximately 25% of total outstanding payments. At the close of the year 2017, total Parish Apportionment outstanding has increased by approximately 13% when compared to the corresponding period of 2016.

1.4 <u>Convention Project</u>

Last year, the 74th Annual Convention designated project was the "Living Reformation Project." This was envisioned by the Youth of the ELCG with the intention of establishing a "Luther Centre" that provides space for seminars, meetings, library and museum.

b. Property –Land and Building

As we continue routine upkeep of the "Hanson House" and its surroundings, we are in negotiation with a prospective Lessee for the renovation and subsequent rental of the premises. We have had further negotiations with the prospective Lessee and a building design was approved by the Executive Council. We are in the process of costing the project and engaging contractors. Once the terms are amenable, we foresee a transformation of the ambience and a guaranteed long term source of income for the ELCG.

2.0 Expenses

During the year we expended 98% of our budget of \$10,250,000: Total expenditure for the year amounted to GY\$10,067,739: of which GY\$5,109,513: was spent from Designated/Special Fund.

2.1 Maintenance

a. "Hanson House," Sheriff Street, Georgetown

Work commenced on the Hanson House renovation project in 2014. So far, we have expended funds to erect a new perimeter fence and to clean the compound of debris. As stated above, we expect to enter into a long term arrangement for the effective stewardship of the property.

b. Lutheran Camp and Retreat Centre, Skeldon, Corriverton

However, the ELCG has received an offer to utilize the property for the purpose of a private school managed by overseas and local citizens. The ELCG had meetings with the prospective Lessees and negotiations are ongoing.

The Mini Bus BJJ 9671 previously used for the Medical Mission was handed over to the ELCG during 2013. The bus was refurbished and we outline the associated costs below:

The ELCG Executive Council has been in discussions with the Transfiguration Parish Council on the use of the parsonage located within the Lutheran Courts compound as the alternative site for the Living Reformation Project.

Consequently, the Transfiguration Parish has been offered the house designated for the Christian Education Director located in Stanleytown, New Amsterdam.

Resulting from meetings and discussions with the Transfiguration Parish and the National Youth Ministry, an agreement was reached that will benefit all parties involved and the wider Church.

We encourage Parishes that have not submitted their audited statements to have their accounts audited and submit same to the ELCG by June 30, 2018.

The ELCG (Executive Council) accounts were audited by our Auditors L.A. Atherly & Company and a copy is attached.

4.0 Finance Administration

A discussion on Finance and Parish Administration was conducted in February 2017 at the joint meeting of the Executive Council and Committees/Parish Councils. This workshop attracted attendance in excess of 30 persons and was considered fruitful and beneficial to all.

Based on discussions held at the joint meeting and a review of Financial Reports for 2017, there is a great need for additional training on finance management that will target Parish Chairpersons and Treasurers.

5.0 Budget

The proposed 2019 budget is set at GY\$12,310,000: This is a decrease of approximately 4.5% of the 2018 Budget.

Based on our anticipated income, we project an overall deficit of GY\$2, 619,000: or approximately 21% of the budget.

In order to further reduce our 2019 financial deficit, we are proposing a 4% increase in Parish apportionment. The proposed contribution per Active member is set at \$2,500 up from \$2,400.

In 2014 Convention approved recommendation 6f which required each Parish to submit to the Executive Council by March 31 annually, their Parish Budgets. We have received submission from the following Parishes:

Good Shepherd
 St Andrew
 GY\$1,351,000: (9.5% increase from 2017)
 GY\$5,400,000: (1.9% increase from 2017)

We remind Parishes to submit their Budgets as soon as possible.

6.0 Observations and Future Outlook

As a Church, how have we done financially? Our net cash movement during the year 2017 was approximately negative 2.34% (GY\$902,208:). This movement was tempered by the generous support of our overseas partners and friends (45%), local support through Parish apportionment (19%) and rental/interest income (11%).

While the movement has not been significant, the foregoing percentages show that we are heavily dependent on external support and we are far from becoming a self-supporting Church.

From a Parish perspective, the financial position has remained fairly stable moving by approximately by 7% in a positive direction.

We highlight below the top three Parishes with the highest financial turnover during the year 2017:

We continue to have a growing concern with Parishes non-payment of apportionment. Again, we reiterate that if this is left unchecked, Parishes will end up harbouring unmanageable financial debts.

We provide below a synopsis of the current position of Parishes as it relates to apportionment debt and debt servicing:

Since approved by the 74th Annual Convention, no Parish proposed a payment plan to the ELCG Finance and Stewardship Committee including justifications and recommendations for relegations. This is despite a total outstanding balance as at January 01, 2017 of \$4,608,247 and a closing balance as at December 31, 2017 of \$5,194,247:

From our review of Financial Statements submitted by Parishes, we further note the following:

- a. The 74th Annual Convention approved the recommendation for systems be put in place to ensure that requests for loans facilitated through the Parishes' treasury whether personal, corporate or otherwise must receive prior approval from the ELCG Executive Council. However, we noticed a personal loan granted by one Parish that has not been brought to the attention of the Executive Council.
- b. One parish has budgeted remuneration for its Chairperson at approximately 75% of Pastor's basic salary. While this gesture may be in good faith, it may set a precedence and require further consideration. Such decision should be referred to the Executive Council for its opinion/approval prior to adoption.
- c. Many parishes include Balance Forward in their Total Income for the year. Total Income should reflect the total amount received during the reporting period.
- d. Financial records of Parishes are audited and signed off by its own members.
- e. Some Parishes have no allocated funds for Youth and Women's ministry.
- f. Maintenance is under-budgeted.
- g. Financial reports are submitted late or incomplete.
- h. Eleven (11) of seventeen financial reports submitted for 2017 have discrepancies with their opening balances as at January 01, 2017. The closing balance as at December 31, of the preceding year must always be the same as the opening balance of the following year.
- i. Balance as per bank Statement differs from Cash Book balance but there were no outstanding/unpresented items reported.

j. Balance as per Cash Book only accounted for the Chequing account balance. This must include all accounts. As such, Balance as per Bank Statement on the Audit Report must include all accounts.

The Executive Council remains committed to and continues its discussion on the way forward as it relates to the following:

- a. Continued dialogue and negotiations on the best possible use of the Camp and Retreat Centre, Skeldon, Berbice.
- b. Ensuring the best returns are received from the sale of the ELCG Bus and the "Hanson Property" which is located in a prime location in Georgetown while being cognizant of the Redeemer Parish's ministry within its environs.
- c. Continue to provide support National Youth Ministry on the Living Reformation Project.
- d. Continually oversee the management of the Church's assets, ensuring effective stewardship is exercised at all times, and where necessary dispose of obsolete/un-utilised assets at the best market price available.
- e. Continue working along with Parishes and provide guidance and support for more effective and self-sustainable Parish ministries.

7.0 Recommendations

I place the following recommendations before the Convention for favourable consideration and approval:

- i. That an increase in Parish Apportionment from GYD\$2,400: to GYD\$2,500 per active member for 2019 be approved by this convention. This represents an increase by GY\$8.33 per month per active member.
- ii. That Parishes cease with immediate having their members audit their accounts. We recommend that the parish engage independent Auditors to perform such functions.

We hope that the foregoing recommendations find favour with the Convention.

7. Conclusion

Once again, I express thanks to the Executive Council and the membership of the ELCG for this opportunity to serve in the capacity of Treasurer. I pray for a successful and blessed 75th Annual Convention.
